- An incident was reported to the Judges about an altercation in the stabling barn area. Judges will follow up.
- Spoke to track management about the use of Test Barn wash racks on non-race days. Track management has been asked to secure the area during the racing season.
- Dustin McClure assessed a 3-day driving suspension (July 18<sup>th</sup>, 19<sup>th</sup> and 20<sup>th</sup>, 2024) from Race 2 for causing interference. AGCO rule 22.09. Ruling #2735883

**Races:**

Race 1 – Clear.

Race 2 – **Inquiry and driver objection** - #1 'Staying Fresh' (finished 4<sup>th</sup>) driven by Dustin McClure, did cause interference in the stretch to #2 'Party Style' (finished 5<sup>th</sup> placed 4<sup>th</sup>) driver Natasha Day, and #4 'Jayport Beach Boy' (finished 6<sup>th</sup> placed 5<sup>th</sup>) driver Louis Gregg. #1 was placed 4<sup>th</sup> to 6<sup>th</sup> for causing interference. #6 'Inukshuk Sally' (finished 6<sup>th</sup>) driver Travis Henry, was placed on the Judges list 'lame' by the Official Vet post-race.

Race 4 – #5 ‘Carsons Shadow’ driver Louis Gregg (finished 8<sup>th</sup>) charted with broken equipment (overcheck). Clear.

Race 5 – **Inquiry** - #2 ‘Illgetmyown Thanks’ (finished 2<sup>nd</sup>) driver Travis Henry, made a break after the start. No violations of the AGCO breaking rules.
