• Reviewed race video from the sixth race on 5 July concerning complaint number 2735258 regarding the #6 SAINT IDES (Jason Woodward) at the start; #6 was in position when the starter released the field although horses 5-8 were slightly off the gate but within one length at the start; there were no violations.

Races:

- Stephen Gassien excused from one drive.
- 1. Reviewed the break by #3 FIERY SHADOW (John Thomson) before the ¾ mile pole; while off stride #3 did cause interference to #2 ROCK SOLID LOVE (Bradley Rae); no placing necessary as #3 finished sixth (last).
 - Reviewed the stretch concerning a possible violation of AGCO rule 22.05.01(e) (allow a horse to pass needlessly on the inside) concerning #4 MAJESTIC VIRGIN (Samuel Fillion); after reviewing the race video and speaking with Mr. Fillion it was determined that the horse was bearing out and there was not a violation. Clear.
- 2. Inquiry on #2 WOODMERE FENN (Ryan Guy) who broke after the start and finished fourth; no violation of the breaking rules by #2 and no placing. Clear.
- 3. Late Judges scratch (other) of #1 MORTGAGE MY VILLA; refund: \$32. Clear.
- 4. The #2 BET ON BRETT (Samuel Fillion) suffered broken equipment (shoe) after the start and finished second with broken equipment. Clear.
