- One second variant allowed as the surface was considered loose by participants.

Inquiry on #3 PULLYOUROWNSTRINGS (Jimmy Gagnon) concerning possibly leaving the course in the final turn; after reviewing the race video it was determined that #3 did leave the course by going inside the final pylon and by doing so did gain an unfair advantage in violation of AGCO rule 18.08.02.01(c); #3 finished fourth placed fifth.

Clear.
