Drivers Colin Kelly and Samuel Fillion both excused from driving. Bob McClure excused from driving in race #6 as he did notify the race office prior to the final changes.

Ruling #2766543 generated – Driver Paul MacKenzie did fail to drive in race #3 without being excused by the Judges. Mr. MacKenzie has been issued a \$100.00 monetary penalty, AGCO rule 6.02(a).
