Race 1, Stewards inquiry and Jockey claim of foul, #1 Carpe Bellum, K. Johnson, 3rd, on #5, Collaborative, E. Zenteno, 1st inside the 3/16ths in stretch. Upon review of the front tower and upper pan camera angles, #5 is going by and drifts in under right-handed urging, interfering with the #1 on the rail, #1 has to check hard.

E. Zenteno felt he kept a straight path.

K. Johnson stated he took my room away

#5 was disqualified from 1st position and placed 3rd. Notice of review for the riders sent.

Race 2, All clear

Race 4, Off turf, All clear

Race 5, Jockey claim of foul, #3, Tonka Wakan, P. Mailhot, 2nd on #5 Follow Me Home, E. Zenteno, 1st, through the stretch. Upon review of the front tower and upper pan camera angles, #3 is outside of the #5, they both come together a few times, it was determined that the contact was evenly distributed and neither rider was forced to stop riding or appeared to be impeded. The claim of foul was disallowed.

#4 You See Me, A Sanchez, 5th lugged out badly into the far turn and was eased, spoke with Sanchez who thought the blinkers may have shifted to impair the horses' sight, reviewed run into the turn. No visible sight of the blinker issue.

Race 6, Jockey claim of foul, #5 M C Jackhammer, D. Gaskin, 2nd on #6 Nameofthegame, M. Buchanan, 1st, going into the far turn. Upon review of the upper pan and back tower camera angles, #6 is outside and in front, #5 inside that one with #4 to the inside of #5. It appears the #6 is clear although it does get tight for #5 inside, does steady his mount. Insufficient evidence to support a placing. Claim of foul disallowed.
