**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

### Backstretch:

Trainer Warren LeBlanc issued a monetary penalty of \$200.00 for failing to have the horse Feelthebeat on Association grounds at Fort Erie at the appointed time necessitating a scratch. TB Ruling #2755757.

Trainer Barbara Bailey accepted the settlement offer for the Flunixin positive analysis for the horse Glorious Tribute from Race 1, July 1, 2024. Three-day suspension to be served July 29, 30 and 31, 2024, and a \$500.00 monetary penalty. Glorious Tribute is disqualified from 3rd position and unplaced. Ruling forthcoming.

Race 1, All clear

Race 2, Rough run after the start with #4, Golden Spring, T. Husbands, 5<sup>th</sup>, #5 Signature Ring, M. Dennis, 6<sup>th</sup>, and #6 Always My Fault, 7<sup>th</sup>. #5 got bounced around as it tightened up, no placings required. Rest ok.

Race 3, Turf, Stewards' inquiry and Jockey claim of foul, #2, Harper City, A Vandermeersch, 4<sup>th</sup>, on #4, Prince for a Day, E. Zenteno, 3<sup>rd</sup>, stretch run. Upon review of the front tower and upper pan camera angles, #4 does drift out into the path of #2 forcing that one to check hard. A Vandermeersch said she was interfered with and felt it cost her a position. E. Zenteno stated his horse drifted after switching leads. #4 was disqualified from 3<sup>rd</sup> position and placed 4<sup>th</sup>. Rest ok. Inquiry video: <https://youtu.be/aGcxh4bYzoQ>

Race 6, Turf, Stewards Inquiry and Jockey claim of foul, #1 Kiddie Holiday, M. Pinto, 6<sup>th</sup> on #3, Sailor's Passion, E. Zenteno, 1<sup>st</sup>, going into the far turn, upon review of the apex, upper pan and back tower camera angles. #3 is outside of #1, at the back of the field, it gets tight as #4 is in front of and to the outside of #3, #1 on the fence bumps the #3's hind end and turns that one in creating the problem, Claim of foul was disallowed and no change made to the order.
