

caused the #3 to check hard on the fence. D. Bynoe claimed the #1, S. Vives, 8th. Was coming back and forced him over making it tight for the #3. K. Kimura said #5 came right over and he almost clipped heels.

No change was made to the order and the jockey claim of foul was disallowed.
