Race 1, Inner Turf, #3 Seattle Down Under, E. Wilson, 6<sup>th</sup>, slight hesitation at start, #4 Phantom Jewel, J. Campos, 7<sup>th</sup> popped up at start. Rest ok

Race 2, Off EPT Turf, operator error for the photo finish, utilized upper pan camera angle in slow motion to determine order of finish, Race all clear.

Race 3, #6, Spellcheck, S. Vives, 7<sup>th</sup>. bore out at start to #7, Shakshuka, E. Flores, 3<sup>rd</sup>. and turned that one in slightly, rest good.

Race 4, Inner Turf, #4, All for Honor, D. Gaskin, 10<sup>th</sup>, off a step slow, #7 Quality Prescence, L. Contreras, 3<sup>rd</sup>, poor start and #9 Design Diva, L. Salles 7<sup>th</sup>, bore in at start.

Race 5, #3 Xarabella, D. Moran, 6<sup>th</sup>, and #11, Bright Sunshine, S. Civaci, 8<sup>th</sup>, off a step slow. Rest ok.

Race 6, Inner Turf, #5 Awasef, P. Moran, 11<sup>th</sup>, was on the bridle early and backed away far turn and eased through stretch, spoke with Apprentice Moran who stated just threw her head and had no run for the stretch.

Race 7, Off EPT Turf, #4, Talbeyah, P. Husbands, 8<sup>th</sup>, off a step slow as 33 Elysian Field, S. Civaci, 1<sup>st</sup> filled the void, reviewed racing inside 1/16<sup>th</sup>. #2, Spansive, R. Hernandez, 2<sup>nd</sup>, does come out slightly approaching finish, #7, Blueberry Fields, R. Munger, is there and hesitates a stride, the space between does not dissipate a there is room, spoke with Munger who felt his horse shied away when it tightened up, no placings required.

Race 8, My Dear Stakes, #2, Lithica, R. Montanez, 8<sup>th</sup>, lugged out badly into and throughout the far turn, rest good.

Race 9, Ballade Stakes, reviewed run from chute onto main track, #1, Veri Gizmo, S. Vives, 4<sup>th</sup>, is taken in hand, the room inside is getting tight as horses are moving laterally left, #2, Lantana Lady, P. Husbands, 3<sup>rd</sup>, is to the outside but does leave room. No placings required. Call from Apprentice Jockey S. Vives who stated she did claim foul with one of Course Marshalls, but the information was not relayed to the Stewards and the Official sign was posted. A subsequent call from Trainer Josie Carroll requesting information why the objection was not lodged. Spoke with lead Course Marshall Rob McKay to inquire why we did not receive the information. Rest good.
