Race 3, Inner Turf, on advisement of the Official Veterinarian, #9, Beer Mosa, was a late scratch at the gate, refund of \$13,341. Race All clear

Race 4, #6 Kid Forester, Leo Salles, did get its head over the front of the stall doors and fractious, prior to the start and again after the start, rest good.

Race 5, EPT Turf, All clear, after the race was official, it was brought to the Stewards attention that the #6, Forest Drift, S. Vives, 2^{nd,} crop may have come into contact with #5, Loopy, J. Campos, 3rd in the head area when racing inside the 1/16 mile marker. NOR for S. Vives

Race 6, Inner turf, Stewards' Inquiry, #4 Lumberyard, K. Nicholls, 2nd, and #5, Forest Woodman, D. Bynoe, 7th, at the start, upon review of the back tower and upper pan, #4 is bumped slightly by #3, Professorridesagain, J. Anderson, 8th, 2nd jump out of the gate, as #3 is slightly of balance, tries to regain balance and veers out sharply to #5. It is apparent that the #5 does not lose any ground after the bump and Jockey D. Bynoe did indicate his horse broke a little slow and it did not affect the outcome. No change was made to the order.

Race 8, EPT Turf, Trainer claim of foul and Jockey claim of foul #9, Quiet Knight, P. Moran, 4th on #8 Fracen Macho, E. Flores, 2nd, through stretch, upon review of the front tower and upper pan camera angles #8 is lugging in as #9 is holding position to his inside does get bumped and has to check his mount.
