### Backstretch:

Jockey Melanie Pinto excused from her mount today.

Jockey Ryan Munger, issued a three-day riding suspension, July 18, 19 and 20, 2024. from race 5 on June 29, 2024. TB Ruling #2735779

### Film Reviews:

Race 8 July 5, 2024. E. Flores, P. Moran, D. Gomez as rep. Mr. Flores did make the effort to correct his mount as it was laying in through the stretch when the two horses came together. The Stewards took no action on Mr. Flores.

### Races:

90 Entries

Race 1, #3 Alpha Meister, R. Hernandez, 6<sup>th</sup>, was very slow at the start, rest ok.

Race 2, EPT Turf, #7 Spirit Bear, J. Campos, 8<sup>th</sup>, steadied far turn when #8 Flip Floppin Fast, L. Seecharan, 6<sup>th</sup> was dropping in, appears to be room for #7, no placings required. Rest ok.

Race 3, on advisement of the Official Veterinarian, #2 Gamble's Dance was scratched at the gate, refund of \$25,402. #6 Princess Rosina, D. Moran 7<sup>th</sup>, dwelt at the start. Rest ok.

Race 4, EPT Turf, #2 Borrowed Bandit, R. Munger, off a step slow.

Race 5, #7 Early Strike unseated Jose Campos while the horses were loading into the gate, ran off and was a Steward scratch, refund of \$31,189. #1 Scary Speedy, J. Anderson, 6<sup>th</sup> and #3, Dancin Mary Marie, O. Moreno, 4<sup>th</sup>, were both off slow, rest ok.

Race 6, Inner Turf, All clear

Race 7, Jockey claim of foul, #8, Silken Dollar, J. Stein, 9<sup>th</sup>, on #11, English Shirl, J. Campos, 3<sup>rd</sup> after the start, utilized Woodbine feed for the start, the Stewards system in the stand was not switched over to the correct feed, back tower and upper pan camera angles, #11 is drifting down couple of paths, #8 does have to steady, the claim of foul was disallowed.
