

Race 5, July 5, 2024. S. Vives, J. Campos and D. Gomez as rep. In the review it was evident that Ms. Vives did inadvertently strike the horse, in the head area, to her inside during the stretch run of the 5th race July 5, 2024. Ms. Vies is issued a \$200.00 monetary penalty for the urging violation. Forest Drift, which finished second is hereby placed third for the interference. The video is attached here.

Races: 77 Entries

Race 1, Inner Turf, Lake Huron Stakes, #3 Junior Hot Shot, bobbled after start, Stewards Inquiry, run into the far turn regarding #1, Yacht Boy, R. Munger, 4th, and #3 Junior Hot Shot, J. Stein, 2nd. Upon review of the back tower and upper pan and apex camera angles, it is very tight for all horses going into the turn and #1 appears to be laying out slightly when Mr. Munger has to check. Mr. Stein felt it got really tight inside and he held his ground.

Mr. Munger said the inside got really tight, pressure from the outside.

No placings required.

Race 2, EPT Turf, #8 popped up and slow at start, rest ok

Race 3, #6 Kekoa, R. Hernandez, 2<sup>nd</sup>, lugged in through stretch. Rest ok. Race 4, EPT Turf, #4 Secret Storm, K. Nicholls, 3<sup>rd</sup>, off a step slow, # 6 Walter Me Lad, O Moreno, had an awkward start, prevailed. Rest ok.

Race 5, #2 April de Velp, J. Crawford, 6th, off a step slow. Rest ok

Race 6, #8, Ontario, S. Vives, was off a step slow, prevailed. Rest good.

Race 7, Inner Turf, Georgian Bay Stakes, Jockey claim of Foul, #5, Olivia Rose, R. Hernandez, 2<sup>nd</sup> on #2 Little Teddy, Kazushi Kimura, 1<sup>st</sup>, top of the stretch.

Upon review of the upper pan and front tower camera angles, #2 is in front and the #6 Strike a Chord, F. Aebly, 3<sup>rd</sup>, moves out slightly from the inside and #5 is just to his outside, as #6 moves out, #5 does as well out to the #2, #5 catches the hind end of #2 turns him slightly, #2 stays straight and no evidence to support any kind of interference from K. Kimura's crop to Mr. Hernandez or his horse.
