Backstretch:

The Stewards held a review with Jockey Pierre Mailhot concerning several security report incidents. On June 24, 2024, Mr. Mailhot was found to be in violation of AGCO rule 16.05 (a) & (b) (made himself obnoxious on the ground of the Association) and is subject to a \$100 monetary penalty. On June 17, 2024, Mr. Mailhot was also found to be in violation of AGCO rule 3.19.03 and Fort Erie track rule 8.8.1 (galloping on the inside rail) and is subject to a \$200 monetary penalty. The rulings will be generated at a later date.

Race 1:

- #5 Moonbright (Da-Sean Gaskin), (finished first) broke outwardly but prevailed.

Race 2:

Jockeys claim of foul and Stewards inquiry #3 Tachyon Speed (Sunny Singh), (finished second) on #4 Princess Bu Cherro (Pierre Mailhot), (finished first) on the first jump. #4 outbreaks the #3 and is coming inward as the #3 breaks outward and ends up on the heels of the #4. The Jockeys claim of foul was disallowed.
