Race 1 – Stewards inquiry into the start regarding #4 “Break the Spell” ridden by Skye Cherntez. The horse stumbled a couple jumps leaving there unseating its rider. No change.

Race 2 – Reviewed the approach to the wire and spoke with Pietro Moran aboard #8 “Amazing Success”. Pietro said the horse to the inside #1 “Dancin’ Deputy” with Jeffrey Alderson came out on me but it was right at the wire and didn’t cost me a position. No action taken.

Race 3 – Clear

Race 4 - #2 "Summer Snow" with Sophia Vives broke through the doors prior to the start, Ms. Vives did a good job at containing the horse and after a vet check, was allowed to compete.

Race 5 - #7 "Tuxedo Park" was a veterinarian scratch in the paddock. Race Clear.
Mutuel refund #7 \$9,019.

Race 6 – Jockey Claim of foul (COF) by Keveh Nicholls aboard #4 "Pat'ssewingmachine" against #2 "Junipero Serra" ridden by Sahin Civaci. Keveh said Sahin made it a bit tight on me and Eswan, wasn't much but thought I should claim foul. Sahin said his horse was bearing in a bit but never bothered anyone. The COF was disallowed. A second COF was lodged by Eswan Flores aboard #5 "Jim's Hope" but was unsure who to claim foul against, Luis Contreras was to his inside on #6 "Gran Spirited" and explained he did come out in late stretch but was clear of Eswan when doing so. Eswan said the three of them were race riding and the hole closed approaching the wire, not sure who was responsible and not sure if it cost him a position. After review, the second COF was disallowed.

Race 8 – Stewards Inquiry and Jockey Claim of Foul (COF) by Pietro Moran aboard #6 "Clayton" against #5 "Forester's Fortune" ridden by Da-Sean Gaskin for a crop infraction approaching the wire. Pietro said Da-Sean was waving his crop in my horse's face eventually making contact. Da-Sean said they were close but never made any contact with Pietro's mount. After review, #5 was disqualified from first position and placed second for inadvertently striking #6 on the nose.

Race 2 - #3 "Chairman Rainbow" goes to owner Logan Friesz for \$7,000. Trainer Alison Jennings. Opted in for observation. Horse did not clear observation and was placed on the vets list for lameness. Trainer Alison Jennings opted to invoke her right to decline the horse and the claim is invalidated.

Race 4 - #1 "Souper Sunday" goes to owner/trainer Dominic Polsinelli for \$15,000. Opted in for observation. Passed observation.

Race 7 - #6 "It's a Fluke" goes to owner Six Brother Stables for \$25,000. Trainer William Tharrenos. The observation request box was not checked off.

Race 11 - #1 "Embrace My Uncle" goes to owner Anthony Di Paola for \$10,000. Trainer Santino Di Paola. Opted in for observation.
