Races:

1. The #1 BAUER POWER (Robbie Robinson) suffered broken equipment (knee boot) after the start and finished with broken equipment. Reviewed the performance of #5 JAYPORT LEXUS (Jean-Francois Gauthier) around the last turn; #5 was inside one pylon and contacted the subsequent pylon; no violation of the inner rail rule. Clear.
2. Driver of #6 SYNERGY, Sylvain Lacaille, was cautioned regarding his urging in the stretch. Clear.
3. Reviewed the break by #2 BESTGIRL IN TOWN (Stephane Pouliot) before the ½ mile pole; while off stride #2 did cause interference to #1 SHADOW DAVE (Mike Healey), #3 BEACH ROLLER (Ryan Guy) and #4 LISBON SEELSTER (Guy Gagnon); no placing necessary as #2 finished seventh (last). Clear.
4. The #4 SHADOW MARGEAUX (Ryan Guy) was examined by the AGCO Veterinarian post race without remark. Clear.
5. Inquiry on #4 BIG PETES STYLE (Jimmy Gagnon), who finished third, concerning possibly leaving the course after the ¾ mile pole; #4 did go inside two consecutive pylons but was not lapped on at the finish by any other horse and therefore there was no violation of AGCO rule 18.08.02.01(a) (inner rail rule) and no placing.
