- Notification of Certificate of Positive Analysis Number 4524200305 from 18 July 2024:
 - Horse: BLACK TIE BASH (2S525) race 7 finished first
 - Trainer: Isabelle Darveau (notified 4 August; will receive disclosure 8 August)
 - Drug: trichlormethiazide and its metabolite chloraminophenamide (class 4)
 - $\circ~$ Ms. Darveau was advised regarding AGCO rule 26.08 (transfer of horses to the care of another trainer).
- Early Judges scratches of WHATS TATOW (transportation; Michel Ouimet trainer) and BETTERTHANHOUDINI (transportation) from the third race (Pierre Marc Longpre trainer), ATEYATENFNGERSLOUIE (weather) from the fifth race (Ryan Guy trainer) and BATTLE OF YORK (weather) from the seventh race (Stephane Pouliot trainer).
- Early Veterinary scratch (lame) of PROBERTS LEGACY (Marc Andre Simoneau trainer); this horse is entered on the short term (seven days) Veterinarians List.

Reviewed racing at the top of the stretch concerning #1 SOUTHWIND MAC (Pascal Berube) possibly leaving the course; after reviewing the race video and speaking with Mr. Berube (stated that the #3 was stopping badly and he moved for safety reasons) it was determined that #1 had gone inside one pylon at the top of the stretch for safety reasons (charted with interference); no violations and no placing.

The #3 BANDURA (Guy Gagnon) must qualify for breaks in two consecutive races on a fast track (trainer Guy Gagnon notified). The #3 was examined by the AGCO Veterinarian post race without remark.
