Trainer Gaetan Hebert was in this evening to review race 5 (OSS Gold: 3 year old colt & gelding trotters) from Wed, Aug 16, 2024; regarding the placing of his horse #5 Mrstery Deal (Jason Ryan, 4P8) for causing interference in the first turn to #3 Northern Looker (Chris Christopherou, 2<sup>nd)</sup> and #1 Soar Hunter (T. Ratchford, 8P7). Mr. Hebert gave verbal intent to appeal. Driver Jason Ryan called re: 3 day driving suspension for causing interference during the race.
