Race 1, No Show or Superfecta wagering, Timer checks complete, 870 yds. Battle of the Breeds, All clear

Race 2, 1st Division, Ontario Sires Stakes Futurity Trial, Timer checks complete, Stewards Inquiry, #1 Runaway Fate, R. Isaacs, 4th, is on a flipping halter, reviewed slow motion front tower camera angle, #1 is moving slightly just before the starter releases the field and pulls sideways hindering the gate stall doors to open slower than the rest. No refund ordered. #3 last Cold Bud, J. Botello, slight stumble at break and #6, Tragically Ripped

Race 3, 2nd Division, Ontario Sires Stakes Futurity Trial, Timer checks complete, #6 Magic in Wonderland, on advisement of the Official Veterinarian, #6 was scratched as it reared up in starting gate, refund of \$2,177. Race All clear

Race 4, No Show or Superfecta wagering, #4 Caraways Magic Rain, reared up in post parade unseating Jockey Diego Benitez and ran off to the backstretch, was corralled but subsequently

scratched by the Stewards, refund of \$454. #2, Caraways Sugar Joe, C. Benitez, 3rd off very slow and ran green through the stretch, #1 Bar Ef Rushfurr candy, R. Isaacs, 2nd, bore out at start to #5, Ms. Fixin to Win, 1st. D. Benitez was cleared by EMS.

Race 5, All clear.

Race 6, Grid Iron Gallop, Stewards' inquiry, #1 A Shades of Gold, B. Bell, 7th, gate stall doors do open slower than the rest when the starter releases the field, is attributed to the horse having equipment of a flipping halter, no refund ordered. #5, Ice Witch, C. Benitez, 6th. off a step slow and gives up the spot after it gets tight, rest ok.
