

Race 1, All clear

Race 2, Reviewed run into the far turn, #5, Lion of the Sea, M. David, 6<sup>th</sup> and #6 Mobilizer, M. Buchanan, 4<sup>th</sup>. The #5 stumbles slightly, film was inconclusive. No placings required.

Race 3, Reviewed run around the far turn, #5, K. Johnson, 5<sup>th</sup>, checks up sharply, spoke with Johnson who stated it got a little tight from the outside but had no issues.

Race 4, Turf, #2 Ami's Girl, M. Buchanan, 4<sup>th</sup>, very fractious loading into gate, taken in hand into the first turn and throwing its head, rest ok.

Race 5, #3 You See Me, M. Dennis, 6<sup>th</sup>, and #4 Beer Mosa, K. Johnson 2<sup>nd</sup>, came together at the start, rest ok. Jockey Pierre Mailhot was unseated galloping out and was excused from his mount in the 7<sup>th</sup>.
