Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

Trainer Alex Patykewich issued a monetary penalty in the amount of \$300.00 for a stable area scratch of Canadian Avro from the 3rd race today. TB Ruling #2789955.

To ensure the integrity of the 165th King's Plate, the AGCO and WEG collaborated to implement a 48-hour surveillance/retention period on all horses entered into the race. Late Friday afternoon the AGCO became aware that the horse "Bedard" was administered a quantity of the prescription therapeutic medication *methocarbamol* (Robaxin) at 12:50PM. The race day medication ban (rule TB 15.38) prevents horses from being administered substances within 24 hours of the post time of the first race of the racing card; the post time for the first race today is 12:25 PM.

Following an investigation, the AGCO Stewards have scratched the horse, "Bedard." Bets placed on this horse will be refunded in accordance with CPMA regulations.

Following the 1st race, Woodbine Racing removed all races from the turf on both courses. Race office and Clerk of the scales fielded scratches.

Race 1, #2 Moddassah, J. Campos, 7th, off a step slow

Race 2, Off Inner Turf, 45 Minute weather delay, heavy rains lightning and thunder, Race All clear

Race 3, #2 Dream Jareem, returned to the paddock for a front shoe repair, slight delay. Reviewed run into far turn, #1, R Hernandez, 7th, and #5, J. Alderson, 5th, horse checked out of its position on the rail, film was inconclusive to the extent where the pressure came from. Spoke with Hernandez who stated they came over and his room diminished. No placings necessary.

Race 4, Off EPT Turf, All clear

Race 5, Off inner turf, Stewards Inquiry regarding #3 Spansive, R Hernandez, upon review of front tower and upper pan camera angles, #3 is deemed to have received a fair start, just refused to break with the field. Inquiry video: https://youtu.be/3mHgyaP9-SU

Race 6, Delay as Jockeys discussed the safety of the surface of the racetrack. Soaring Free Stakes, Upon request of trainer Graham Motion #2 Test Score was declared out of this race.

At 4:40 PM, a collective decision was made by Woodbine, the Jockeys and Officials to cancel the remainder of the card of racing due to unsafe racetrack conditions.
