Film Reviews:

Review with Sahin Civaci regarding the stretch run of the seventh race on Sunday August 4. Mr. Civaci explained that the brim of his helmet cover was a flimsy one which came down obstructing his line of sight. He realized the optics were not good and apologized for the mistake.

Races:

Race 1 – #2 "Commander At Sea" ridden by Da-Sean Gaskin was away slow.

Race 2 - #3 "Glenrosa" was scratched by the official veterinarian in the Paddock. #8 "Magnetize" ridden by Kirk Johnson was fractious at the gate and scratched by the official veterinarian. Total Mutuel refund for the two horses is \$26,000

Race 3 – Stewards Inquiry into the start regarding #3 "So Called Vacation" ridden by Sophia Vives and #4 "Quandale" ridden by Jeffrey Alderson. Jeffrey said the #3 broke out into his path and caught that one's heels, lucky not to go down. Sophia said her horse broke out first jump but grabbed and corrected as quick as I could. After review, it is apparent the #4 did clip the heels of

#3 when that one broke into its path shortly after the start, therefore #3 was disqualified from second and placed fourth behind #4.

Race 6 - #3 "Apophis" with Rafael Hernandez broke through the doors prior to the start and scratched by the official veterinarian. Mutuel refund \$127,588.

Stewards Inquiry and Jockey Claim of Foul (COF) by Pietro Moran aboard #5 "Side Street" against #1 "Wyoming Bill" ridden by Ryan Munger for interference in the middle of the far turn. Ryan said his horse doesn't like to be on the rail and purposely stayed in the two to three path down the backstretch and around the turn, never changed my path. Pietro said Mr. Munger and his horse came out a bit around the turn and we lost some momentum, finished strong, may have cost me a position. After review, the video is inconclusive and the COF was disallowed, no change.
