R10 from August 10 – Jockeys Fraser Aebly, Leo Salles, Pietro Moran were in to review racing before the $\frac{1}{2}$ mile pole where pressure from the outside causes Salles to take a hold and Moran to pull back and bounce off the fence. The interference resulted in the placing of #7 Whiskey N lce (Fraser Aebly) from 3^{rd} place to 8^{th} . Mr. Aebly felt he was clear. Mr. Salles said he had to take a hold to protect the inside. Mr. Moran said he was yelling.

R8 from August 10 – Reviewed racing from out of the gate with a number of jockeys and discussed how educational film reviews will benefit all riders moving forward.

R1 – Stewards will follow up with trainer David Cotey about #4 Buttered Toast be incorrectly entered and racing with no hind shoes.

R2 – #1 Big Lew (Skye Chernetz, 8th) appears to be trying to run out the gap at the start. Claim of foul declared by #7 (Eswan Flores, 2nd) on #2 Southern Style (Rafael Hernandez, 3rd) at the ½ pole for possible interference with the whip. The video does not support the claim.
