

#### Backstretch:

Trainer Juan Pablo Silva did not have his horse "Daddy Classy Dill" on the grounds at the designated time. The horse was scheduled to compete in the sixth race today. Mr. Silva said he thought it was going to rain today and be taken off the turf, so he did not ship the horse. We advised it is not raining and races scheduled for the turf remain on. Mr. Silva was issued a monetary penalty of \$300.00. AGCO ruling #2821612

Security attended on behalf of Trainer Angelle Carter who found a plastic scoop with a white powder residue inside the stall next to her horse "Dixie Morning". The horse is slated to run in todays fifth race, however, Angelle was not comfortable running the horse due to the situation so the horse was scratched.
