- Early Veterinary scratches of LADY GAMBLER (lame; Thierry Vandenplas trainer) from the first race and JON SNOW (sick; Michael Armstrong trainer) from the sixth race; these horses are entered on the short term (seven days) Veterinarians List.
- Early Judges scratches (injured) of REALRUBIES AT PLAY (Michel Lagace trainer) from the third race and HARDOO PARKING (Darcy Clancy trainer) from the seventh race.

- Steve Germain and Jacques Beaudoin each excused from one drive.
- 1. The #7 CORN FLAKES (Robert Robinson) must qualify for breaks in consecutive races on a fast track (trainer notified). Clear.
