R3 – Clear. Reviewed break on #4 Jimmy Whispers (J. Ryan, 6<sup>th</sup>) before the start. Horse broke on its own. No violations.

Trainer Jason Woodward did fail to take the horse #1 Acefortyfour Duke directly to the test barn following race 3. A \$200 monetary penalty was issued for violation of AGCO Rule 9.11 – Ruling #2837576
