Ruling #2839804 generated Trainer Daryl Bontrager did make a late equipment change on "Gruesome Twosome" in race #9. Mr. Bontranger issued a \$200.00 monetary penalty. AGCO rule #22.25.

Ruling #2839832 generated Trainer Ake Svanstedt did make two late equipment changes on two separate horses (Flying Kronos S and Amazing Catch) in race #9. Mr. Svanstedt issued a \$400.00 monetary penalty (\$200 x 2). AGCO rule 22.25.
