## Office:

- The Judges held a review with trainer Lindsey Kerr regarding a certificate of positive analysis for the Class 4 medication Dexamethasone on the horse Earlybird Special, winner of R8 at Clinton Raceway on August 25<sup>th</sup>. Ms. Kerr has entered into a settlement agreement and will serve a full suspension September 15-17, 2024 (inclusive). Ms. Kerr has also been issued a \$500 monetary penalty and must complete the Equine Medication Use and Awareness Program.
- Sporty Bobbi was ineligible to qualify as his owner Stephen Roberts is currently not in good standing with Standardbred Canada.
- Driver Lorne House was issued a \$50 monetary penalty for failing to fulfill his driving engagement in R1. AGCO rule 6.02 (a). Ruling #2829714

## Races:

R1 – #7 Last Hall (S. Wray, 7<sup>th</sup>) made a break in stride after the start and remained off stride for the rest of the race. The rest of the race was clear.
