- Virtual review held with driver Pierre Bovay regarding his urging while driving EMMA TOWN BUD in the fifth race on 3 October; after reviewing the race video and discussing the urging rules and requirements an official warning was entered on the licence of the participant regarding AGCO rule 22.23.03(b) (more than acceptable wrist action).
