### Office:

- Resulting from a review held with Dany Mainguy on 20 October regarding incidents in the test barn and/or paddock on 29 August and 12 September Mr. Mainguy is adjudged guilty of violating AGCO rules 6.17(c) (improper language), 6.17(d) (improper conduct) and 6.20(b) (misconduct prejudicial to the best interests of racing) and is assessed a full suspension of 45 days (3 November to 17 December 2024, inclusive), a monetary penalty of \$3000, has conditions entered on his licence pertaining to entering the test barn and contact with Veterinary Technicians at Rideau Carleton and is required to complete a workplace harassment course acceptable to the AGCO prior to reinstatement (Number 2886254).
- Early Judges scratch (ineligible) of CB CAPER (Michael Armstrong trainer) from the first race.
- Early Veterinary scratch (sick) of GOING YARD (Stephane Pouliot trainer) from the eighth race; this horse is entered on the short term (seven days) Veterinarians List.
