Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early Veterinary scratches of BATTLE OF YORK (sick; Stephane Pouliot trainer) from the third race and AVID (lame; Denis Audet trainer) from the ninth race; these horses are entered on the short term (seven days) Veterinarian's List.
- Early Judges scratch (transportation) of BETTOR HALF (JF Maguire) from the ninth race.
- Review held with driver Kyle Forgie regarding his urging while driving MONTYSGONEMARBLE in the fourth race on 26 September; after reviewing the race video, discussing the urging rules, with specific reference to AGCO rule 22.23.02(b) (horse not in contention for a meaningful position), an official warning was entered on the licence of the participant.
- Review with driver Kyle Forgie regarding a possible violation of AGCO rule 5.11 (failure to comply with Judges' directions) by failing to appear before the Judge's after being served a Notice of Review on 29 September; after discussing the requirement to contact the Judges forthwith when requested to do so Mr. Forgie was adjudged guilty of violating this rule and assessed a \$100 monetary penalty and is fully reinstated (Number 2863831).
- Review with driver Guy Gagnon concerning a possible violation of AGCO rule 22.05.01(k) (pace comparable to class) while driving BEACH JOURNEY in the eleventh race on 19 September; considering the class, race dynamics and the explanation of the participant no regulatory action is required.

4. Reviewed racing before the ½ mile pole when #4 HOWIES MAN (Joshua Miller) relinquished the lead to #1 CARSON STAR CHOICE (Guy Gagnon); no violations. Clear.
5. Reviewed the performance of #4 DYLAN'S BANK (Jimmy Gagnon) before the ¼ mile pole; #4 did contact several pylons but did not leave the course; no violations. Clear.
6. Late Judges scratch (injured) of #2 STORMONT FRIENDLY; refund: \$205. Reviewed breaks by #3 SOUTHWIND MAC (Jimmy Gagnon) who broke before the ¾ mile pole and finished fifth and #4 BANDURA (Guy Gagnon) who broke after the ¾ mile pole and finished sixth; no violation of the breaking rules by either horse. Clear.
7. The driver of #7 ARIZONA JACKSON, Clarke Steacy, was cautioned regarding his urging in the stretch. Clear.
8. Late Veterinary scratch (lame) by the AGCO Veterinarian of #8 ROCKINMYDREAM (Pascal Berube); this horse is entered on the short term (seven days) Veterinarian's List; refund: \$1712. Clear.
