IN THE MATTER OF THE *HORSE RACING LICENCE ACT, 2015*, S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF Kenroy S Scafe

On August 18, 2023, the Alcohol and Gaming Commission of Ontario ("AGCO") was advised of a positive reading for the Class 5 substance Furosemide EIPH quantified at 142 ng/mL in the Blood sample with Test Tag # 37 23219 309 E. The sample was obtained from the standardbred horse ALLGONOWHOA (tattoo number 8N226), which finished first (1st) in the Third (3rd) race on August 7, 2023, at Grand River Raceway. At that time, ALLGONOWHOA was trained by Kenroy SCAFE (licence # HP144978) (SCAFE).

This is a second violation occurring within three (3) years of the first violation of the same class.

On September 8, 2023, the AGCO was advised of a positive reading for the Class 5 substance Furosemide EIPH quantified at 206 ng/mL in the blood sample with Test Tag # 37 23235 319 E. The sample was obtained from the Standardbred horse ALLGONOWHOA (tattoo number 8N225), which finished second (2nd) in the tenth (10th) race on August 23, 2023, at Grand River Raceway. At that time, ALLGONOWHOA was trained by SCAFE.

This is a third violation occurring within three (3) years of the first violation of the same class.

TAKE NOTICE that SCAFE has violated rules 9.09(b), 26.02.01, 26.02.02, and 26.02.03(c) of the Rules of Standardbred Racing (the "Rules").

In accordance with rules 4.02(i), 6.04, and 9.08.02 of the Rules and Policy Directive No. 1- 2018, SCAFE is hereby issued a monetary penalty of \$1000 for the August 7, 2023 positive test, and \$1500 for the August 23, 2023 positive test, for a total monetary penalty of \$2500.
