

Kimura yelling so I stayed with Jeff **#8 Quandale (Alderson)** (8th) trying to stay outside. I tried to help Kimura". **Alderson** "My horse had its head cocked, and switched leads on the turn dropping down some, but I stayed out for the most part". Video footage revealed #8 put pressure on #5 who in turn made things tight on the #4. #8 finished last, therefore no change to the order of finish.
