His horse was tiring, and I was going to get him if he didn't bump me". Contreras "He hit my horse from behind, bumped her on the hind leg. I switched my whip trying to stay off him". After reviewing video footage, stewards determined #8 bumped #9 impeding the horse's path which resulted in a disqualification. #8 finished 3rd and was placed 4th behind #9.
