**IN THE MATTER OF THE *HORSE RACING LICENCE ACT, 2015,*  
S.O. 2015, c.38, Sched. 9;  
AND IN THE MATTER OF Barbara J. Bailey**

On July 14, 2024, the Stewards at Fort Erie Racecourse received a certificate of positive analysis for the Class IV medication Flunixin, identification 71 24183 303, the sample was obtained from the horse "Glorious Tribute" owned by Jennifer Guitterez and trained by Barbara Bailey, which finished third (3rd) the first (1) race on July 1, 2024.

On July 21, 2024, Ms. Bailey attended the Stewards office at Fort Erie to deal with the matter. A settlement agreement was offered and applied to in this case. Ms. Bailey accepted the settlement agreement.

Take Notice that Trainer Barbara BAILEY (HP114630) is hereby issued a three-day (3) suspension, July 29, 30 and 31, 2024, inclusive, and a monetary penalty in the amount of \$500.00, payable at the completion of the suspension. The suspension of Ms. BAILEY is effective for horses racing in the Province of Ontario and during the suspension Ms. BAILEY is denied access to any Association grounds except for grandstand privileges. Any horses that are to be entered to race that were previously trained, but not owned, by Ms. BAILEY during the suspension must be transferred to another trainer in good standing and approved by the AGCO Stewards.

In accordance with AGCO TB Rule 15.04.03, the horse "Glorious Tribute" is hereby unplaced from the first (1st) race at Fort Erie Racetrack on July 1, 2024, for all purposes with the exception of pari-mutuel wagering and all purse money earned is to be returned to Fort Erie Association for redistribution.

The revised order of finish for the first (1st) race on July 1, 2024, is as follows:

1st- Grand Gizmo  
2nd- Carpe Bellum  
3rd- Fifth Season

4th- Same Again Doc  
Unplaced- Glorious Tribute
