**IN THE MATTER OF THE *HORSE RACING LICENCE ACT, 2015*,
S.O. 2015, c.38, Sched. 9;
AND IN THE MATTER OF Robert P. Tiller**

On the 3rd day of October, 2024, Bureau Veritas Canada (2019) Inc. issued a certificate of positive analysis, from a urine sample, Test Tag #73 24265 331, for the Class 4 drug TRICHLORMETHIAZIDE and its metabolite CHLORAMINOPHENAMIDE.

The sample was obtained from the horse "FOREST DRIFT" trained by Robert P. TILLER. "FOREST DRIFT" finished third in the 5th race on the 21st day of September 2024 at Woodbine Racetrack. Take notice that Trainer Robert P. TILLER, having accepted the settlement agreement, is hereby issued a monetary penalty in the amount of \$500.00, payable on or before the 24th day of October, 2024, and a 3 day full license suspension to be served October 22nd, 23rd, and 24th, 2024. The suspension of Mr. TILLER is effective for horses racing in The Province of Ontario, and during the suspension Mr. TILLER is denied access to any Association grounds except for grandstand privileges. Any horses that are to be entered to race that were previously trained, but not owned, by Mr. TILLER during the suspension must be transferred to another trainer in good standing and must be approved by the AGCO Stewards.

AGCO Rules of Thoroughbred Racing 15.04.01, 15.04.02.01, 15.04.03, 15.05.01, 24.04, and 16.13(c)(d)

In accordance with AGCO TB Rule 15.04.03, the horse "FOREST DRIFT" is hereby disqualified from the 5th Race on the 21st day of September 2024 at Woodbine Racetrack for all purposes, with the exception of pari-mutuel wagering, and all purse money earned is to be returned to the association for redistribution.
