Mr. Civaci has been assessed a 3-day riding suspension, days to be announced.

#5 Double Ride (Gaskin) stumbled shortly after break, rest clear.

Stewards' Inquiry into run around the far turn (inside 3/8), and Jockeys' Claim Of Foul #1 Ok Speedy (Wilson) (4<sup>th</sup>), #6 You and Me Baby (Aebly) (3<sup>rd</sup>) against winner #7 Call Me Sue (Fukumoto). Wilson "I almost went down, the #7 dropped over on Fraser causing his horse to impede mine. Both of us were yelling at Daisuke". Aebly "The seven-horse kept coming down, coming down and squeezed me...I was trying to stay straight and ride my race". Fukumoto "I was tracking the five and kept in my lane, didn't move in or out". Video review was inconclusive, no change in order of finish.
