

Horse was ok and rider was cleared by EMS, no change was made to the order of finish. Due to the nature of the incident, video is not part of this report.

Race 3 – Stewards Inquiry regarding the run down the backstretch involving #7 "Frac Right" ridden by Sahin Civaci and #3 "Olympic Fencer" ridden by Fraser Aebly. Fraser said Sahin came over in front of me real fast and I hit his heels hard, thought I was going down, I didn't claim foul because I finished last. Sahin said his horse is a bit difficult to ride and went in with him but he was unaware that he bothered Fraser. After review, #7 "Frac Right" was disqualified from first and placed last behind #3 "Olympic Fencer".
