Race 1 – Clear

Race 2 – Stewards Inquiry regarding #1 “Ready Shakespeare” ridden by Emma-Jayne Wilson fell approaching the half mile pole, there was no interference and no change was made to the order of finish. Given the nature of the incident, video review will not be added to this report. Emma will be off her mounts the remainder of the day.

Race 3 – Stewards Inquiry and Jockey Claim of Foul (COF) by Kazushi Kimura aboard #9 “Rose of Sharon” against #11 “Peace Posey” ridden by Eswan Flores for interference mid stretch. Kazushi said the outside horses came over on me and had to check and get out of there. Eswan said the horse to his outside came over on me, I would have claimed foul on the #2 but I finished ahead of him. After review, the COF was disallowed and there is no change in the order of finish.

Race 4 - #2 “Hello Ladies” ridden by Diasuke Fukumoto broke awkwardly and the rider lost his stirrup, said he was able to regain the stirrup, but he was already out of the race so galloped him around. Advised that next time he should pull the horse up when it’s safe.

Race 5 – Jockey Claim of Foul (COF) by Skye Chernetz aboard #7 “Stylish Gent” against Juan Crawford riding #1 “Wilberforce” for hitting her and her horse during the stretch run. Juan said he never hit her or her horse, not once. Skye said Juan hit her horse over the head and also hit me. After review, the video does not support her allegation. COF was disallowed.
