

#### Film Reviews:

Review of yesterdays eighth race involving Luis Contreras and Sahin Civaci for interference in late stretch. JBAC Manager Daren Gomez and Larry Attard were present. Luis said his horse was lugging in with him but he had control of his horse when he felt Sahin's horse catch his hind quarters turning him into that one. Sahin said Luis was doing all he could to keep his horse off me but near the finish he came into me just when I felt my horse was picking him up. No action taken against Luis for the disqualification, made the effort to keep straight.

Race 1 - #8 "Phantom Jewel" ridden by Da-Sean Gaskin was away slow

Race 2 - Clear

Race 4 – #6 "Mizzen Ash" ridden by Leo Salles was away slow

Race 5 - Clear

Race 6 - #7 "Watsonville Red" ridden by Jose Campos stumbled badly leaving the gate. Spoke to Sahin Civaci aboard #10 "Special Session" and his actions around the clubhouse turn and into the backstretch. Sahin said the horse has a dead mouth and I couldn't hold him, he wants to run up on heels. Did it to me on the turf last time I rode him.

Race 7 - Clear

Race 8 - #1 "Hawkesbury" ridden by Fraser Aebly was away awkwardly

Race 9 – The Cup and Saucer Stakes – Stewards Inquiry and Jockey/Trainer Claim of Foul by Emma Wilson/Michael DePaulo #4 "Ready for Candy" against #1 "Ashley's Archer" ridden by Sofia Vives and #5 "No Time" ridden by Vincent Cheminaud for interference mid stretch. Emma said she had a clear run, lost my room when between the two horses, lost all chance. Mr. Cheminaud said he kept straight until horses from the inside came out and into my horse's hind end and knocking my horse off stride. Sofia said the inside pushed me out but Emma wasn't in there, they are two year olds you know. After review, #1 "Ashley's Archer" was disqualified from first and place fifth behind #4 for going out into that one's path.
