#### Office:

- NCRHHA President Gordon McDonald attended regarding racing issues.
- Early Judges scratches (transportation) of MICKYMAKSOMESPEED from the sixth race and PROBERTS LEGACY from the fourth race (Marc Andre Simoneau trainer).
- Early Judges scratch (ineligible) of MR HOUDINI (Fannie Beaulieu trainer) from the eighth race as this horse was declared on the EIPH program and the documentation placing the horse on the program was improperly completed.
- Following a review with driver Mike Healey, Judges Brethour, Rourke and Counsell have levied a driving suspension of three days (7-9 December, inclusive) against the participant for violation of AGCO Standardbred rule 22.05.01(h) (strike another sulky) while driving KEYSTONE PRESTIGE in the ninth race at Rideau Carleton on 14 November (Number 2920814).

5. Reviewed racing between the race winner #1 RONDA DU LAC (Pascal Berube) and #3 BEACH JOURNEY (Guy Gagnon) who finished third before the ¾ mile pole; #3 did have sufficient clearance to come out; no violations.

Inquired of the driver of #5 LA COEUR CHAPEAU, Robert Shepherd, regarding his foot movement in the stretch; the explanation of Mr. Shepherd regarding pulling the inside ear plug was accepted. Clear.

Inquiry concerning the #2 MEADOWBRANCH NOBLE (Guy Gagnon), who finished first, and #5 RIPPED AND READY (Jimmy Gagnon), who finished third, possibly leaving the course in the last turn; both horses did leave the course by going inside two consecutive pylons; #2 was lapped on by #3 ROSE RUN WHY NOT (Pascal Berube) and was placed second (AGCO rule 18.08.02.01); #5 was not lapped on and therefore there was no placing.

Inquiry and driver's objection concerning possible interference by #1 BANDURA (Guy Gagnon), who finished second, to #2 DOMINION (Pascal Berube) after the ¼ mile pole; after reviewing the race video and speaking with both drivers (Mr. Berube stated that #1 had come out, hit the front leg of his horse causing a break (charted with an interference break); Mr. Gagnon stated he had moved out first) the objection was upheld; #1 finished second placed ninth (AGCO rule 22.09).
