Race 1, #1 Puzzlement, S. Chernetz, 5th, broke upwardly at the start, #2 Somekinda Mischief, L. Contreras, 4th, is very light mouthed as Contreras tries to take a hold and does move off the rail. Jockey claim of foul, #6, Chambers, R. Hernandez, 3rd, on #5, War of Destiny, S. Civaci, 1st, run down the backstretch, upon review of the back tower and upper pan video angles, #5 is outside and directly behind #4, the #2 on the inside does push out making, and forcing #6 to check taking a strong hold. Mr. Hernandez felt that #5 could have given him some room. Mr. Civaci stated he was in jeopardy of going on heels of the #4 if he was to go out. The claim of foul was disallowed as it was determined #2 the major contributor.

Race 2, Jockey claim of foul, #3 L. Salles aboard Clive Cross, 4th on #5, F. Aebly, aboard Stephen B. Good, 3rd, top of stretch, upon review of the front tower and upper pan camera angles, #4, A. Adams to the inside of the of the #5, is switching his crop from right hand to left and his mount does go out and cause interference to the #3. #3 goes out to the #5 and turns that one in. The claim of foul was disallowed as the #4 created the interference. Spoke with Austin Adams and cautioned him on his actions at that point of the race .

Jockey Eswan Flores issued a \$200.00 monetary penalty for raising hand above head level when making contact with his mount during stretch run. TB Ruling #2897414.

Race 3, Inner turf, #6 Sooner Lunar, D. Moran, fractious prior to the start, left flat footed and slow, trailed throughout, outdistanced, rest ok.

Race 4, #1, S. Civaci, 4th, horse is down on the inside hesitant to go in and taken in hand by Civaci and throws its head up. Reviewed stretch run #6 D. Fukumoto, 2nd and #7, K. Kimura, 3rd, #6 drifts out slightly to #7, alters to the inside. Does appear to be clear. No placings necessary.

Race 5, #7, Last Ride, S. Chernetz, 9th, hesitated at the start, rest good.

Race 6, #1, Twisted Romance, 6th, lugged out after the start, rest good.
