- The Association Veterinarians on duty today are Dr. Oscar Calvete D.V.M. & Dr. Brett Anderson D.V.M.
- **From race seven yesterday:**
- #3 Seattle Causeway (\$5,000), Owner: Bruno Schickedanz, Trainer: Devon Gittens. Opted in for observation and was cleared by the Association Veterinarian.
- #8 Dreaming of Audrey (\$5,000), Mark A. Cornett, Trainer: Nigel Burke. Opted in for observation and was cleared by the Association Veterinarian.
- **From race eight yesterday:**
- #4 Ondine Lady (\$15,000), Owner: Bruno Schickedanz, Trainer: Devon Gittens. Opted in for observation and was cleared by the Association Veterinarian.
- AGCO ruling #2922386 generated for Trainer Renaldo Holder concerning #2 The Swayze Express in race seven today. The horse required a work as he was outside thirty days. Mr. Holder was found to be in violation of AGCO rules 6.28 & 6.30.01 (*A licensee shall be*

*responsible for the eligibility of horses entered by him/her*). Mr. Holder is subject to a \$300 monetary penalty.

**Race 1:**

- Stewards' inquiry and Jockeys claim of foul in the vicinity of the 3/8 pole, #1 Porshas Run (Austin Adams), (finished second and was placed first) on #7 Whiskey N Ice (Leo Salles), (finished first and was disqualified). #7 finished first and was disqualified for causing interference to several horses in the vicinity of the 3/8 pole. Video clip is unavailable.
- The following Jockeys have been excused from the remainder of their mounts on today's card. Juan Crawford, Edgar Zenteno, Da-Sean Gaskin, Justin Stein and Fraser Aebly.
