- The following riders were excused from their mounts today. Da-Sean Gaskin, Edgar Zenteno and Justin Stein.
- From the Stewards review yesterday with Jockey Leo Salles (*race one on Friday November 22, 2024*). Mr. Salles was found to be in violation of AGCO rule 11.07 (*interference violation*) and is subject to a seventeen-calendar day riding suspension that shall be served from November 29, 2024, through December 15, 2024, inclusive. AGCO ruling #2924096.
