## **Regulatory Fees for Convenience Store Licence and Grocery Store Licence** Alcohol and Gaming Commission of Ontario Board Resolution

May 23, 2024

WHEREAS Regulation 746/21 made under the Liquor Licence and Control Act, 2019 defines a "convenience store" and a "grocery store";

AND WHEREAS Regulation 746/21 allows a convenience store or a grocery store that holds a convenience store licence or a grocery store licence to keep for sale, offer for sale or sell certain types of liquor in stores operated by the licensee;

AND WHEREAS section 13 of the Alcohol and Gaming Commission of Ontario Act, 2019 (the "Act") provides the Board with the power to establish fees or other charges, subject to the Approval of the Minister, for the administration of the Acts described in section 3 of the Act or the regulations made under them, including the Liquor Licence and Control Act, 2019.

## THEREFORE, Be It Resolved That:

- 1. The Board of the AGCO establishes, subject to the approval of the Minister, fees for the administration of the Liguor Licence and Control Act, 2019 set out in Schedule 1 attached to this Resolution;
- 2. The fees established and set out in Schedule 1 shall be subject to an annual adjustment every April 1<sup>st</sup>, at a factor equal to the reported annual inflationary rate of change to Ontario's Consumer Price Index ("CPI") for the preceding year as calculated and published by Statistics Canada. In the event that Ontario's CPI is zero or negative, no fee adjustment shall be implemented.
- 3. The portion of Schedule "A" to the Board Resolution of November 12, 2021 that sets out the fee for a "Renewal - Beer and cider grocery store licence (Category A) and Beer and wine grocery store licence (Category A)" as well as the portion of the Schedule "A" that sets out the fee for a "Renewal - Beer and cider grocery store licence (Category B) and Beer and wine grocery store licence (Category B)" is superseded by this current Resolution and the fees set out in Schedule 1.
