

Office: A Notification of Positive Analysis was received on Twin B Archie for the Class IV drug methyprednisolone, Race 4 on Monday December 9th, 2024. Trainer Gabriella Sasso was notified and will pick up disclosure tomorrow.

From Race 3, on December 19th, 2024, driver Jimmy Gagnon was found in violation of AGCO Rule 22.05.01(a), did cause interference and make another horse go off stride in the stretch while driving Geishas Treasure. Mr. Gagnon is suspended from driving from December 31st, 2024 to January 2nd, 2025 inclusive. Ruling #2957794.

From Race 6, #6 Acapulco Sunburn was scratched ineligible as the horse was in the Isabelle Darveau stable, left there to the Benoit Hebert stable where a transfer was completed. However, a second trainer transfer was needed as the horse left the Hebert stable to the Brett Lester stable while the original trainer (Darveau) is still suspended.
