From Race 3 on December 7<sup>th</sup>, 2024 driver Tyler Borth was found in violation of AGCO Rule 22.05.01(a), did come out and cause interference to another horse in the stretch and is suspended from driving from December 29<sup>th</sup>, 2024 to December 31<sup>st</sup>, 2024 inclusive. Ruling #2958492.

From Race 6 on December 19<sup>th</sup>, 2024 driver Scott Young was found in violation of AGCO Rule 22.19, did allow his foot to come into contact with the horse Spin For Life. Scott Young was suspended from driving for five days from December 29<sup>th</sup>, 2024 to January 2<sup>nd</sup>, 2025 inclusive and issued a \$300 monetary penalty. This is his second offence of AGCO Rule 22.19 in a 365-day period. Ruling #2958516.
