Office: Horseperson Gabriella Sasso entered into a settlement agreement and renounces her right to appeal regarding a certification of positive analysis for the Class IV drug methylprednisolone on the horse Twin B Archie from Race 4 on December 9th, 2024. A monetary penalty of \$500 and a full suspension from January 3rd, 2025, to January 5th, 2025, was applied. All purse money must be returned, and Ms. Sasso must complete the AGCO Equine Medication Use and Awareness program. Ruling #2962405.
