### Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents) ....

Office: From Race 7 last night, the judges did review the stretch drive where the horse on the lead #7 Saulsbrook Feisty (Trev.Henry), finished 9<sup>th</sup>, went tight to the pylons, was over two and allowed #6 Sweet Cravings (T.Borth), finished 2<sup>nd</sup>, to escape from the pocket. AGCO Rule 22.05.01(e) states: it is a violation to allow another horse to pass needlessly on the inside or **commit any other act that helps another horse to improve its position**. The judges determined that driver Henry was not in violation of the second part of this rule as he did not leave the racecourse. If a wheel of Henry's bike been clearly inside the pylons he may have been found in violation of the above rule.

From Race 5, trainer R Joseph Squires was assessed a \$100 monetary penalty, stable error scratch of the horse Matts Gem. AGCO Rule 20.03.01(i). Ruling #2986934.
