As a result, #5 finished 3<sup>rd</sup> placed 4<sup>th</sup>. No penalty to Borth as the horse is visibly running out.

The front tower video shows #5 bears out towards #3 and hooks the fork on the wheel of #3. On the pan video, the Judged ruled that the contact by #5 impeded the progress of #3. As a result, #5 finished 1<sup>st</sup> placed 2<sup>nd</sup>.

The front tower shows #2 moves out of the two-hole and does not have clearance. The low pan video shows #2 puts a wheel under and touches the hind leg of #7.
