Race 4 – Reviewed pylons on #8 Starbets (S. Wray, 4<sup>th</sup>) in the first turn. #8 was over one, inside one pylon and over another pylon. No violations.

Race 5 – Clear. #3 Soda Queen looked rough at the start of the race but then raced well and finished third. The Official Veterinarian examined the horse after the race and reported that the horse vet checked okay.
