Race 1: #3 Thirdtimesthedream and #4 Allsummerlong As were charted with interference from the break of #2 Jokic before the quarter pole.

#2 Jokic must qualify for breaks.

Race 2: Clear.

Race 3: #10 Woodmere Denver, finished 3rd, was inside 2 pylons around the last turn but was not lapped on at the finish, therefore no violation of the AGCO pylon rules.
